5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee amounting to **Ten Thousand Pesos (Php 10,000.00)**.
6. CASURECO III will hold the Pre-Bid Conference and the Opening of Bid (date and time stated above) at **CASURECO III Function Room, San Isidro, Iriga City** which will be open to all interested parties who qualify and **who have purchased bidding documents.**
7. Bids must be delivered to the address below on or before (date and time stated above). All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the BIDDING DOCUMENTS FOR THE HIRING OF SECURITY SERVICES REQUIREMENTS FOR THE YEAR 2020.
8. The Delivery Schedule/Completion of Project is within **two (2) years** upon receipt of Notice to Proceed.
