Invitation to Apply for Eligibility and to Bid for the "Supply of Labor, Equipment and Materials for the Installation and Commissioning of Connection Point Protection, and Supply of Equipment for Temporary Power Transformer at San Jose Substation"

- 1. The Occidental Mindoro Electric Cooperative, Inc., (OMECO) through the Rural Electrification Financing Corporation (REFC) Loan intends to apply the sum of Ten Million Five Hundred Fifty Thousand Four Hundred Sixty One Pesos & 18/100 (PHP 10,550,461.18) being the Approved Budget for the Contract (ABC). Bids received in excess of the ABC shall be automatically rejected at the bid opening.
 - 2. OMECO now invites bids for the Supply of Labor, Equipment and Materials for the Installation and Commissioning of Connection Point Protection, and Supply of Equipment for Temporary Power Transformer at San Jose Substation. Completion of the Works is required within sixty (60) calendar days including testing and commissioning reckoned from receipt of Notice to Proceed (NTP). The description of an eligible bidder is contained in the Bidding Documents, particularly, in the Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act" and 2017 Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives Implementing Rules and Regulations (IRR) of Republic Act (RA) 10531.
 - Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives and partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 4. Interested bidders may obtain further information from OMECO Bids and Awards Committee (OMECO-BAC) and inspect the Bidding Documents at the address given below during Monday to Friday from 8:00 AM to 5:00 PM, Philippine Standard Time, except Holidays.
- 5. A complete set of Bidding Documents may be acquired by interested bidders from March 18, 2020 (office hours 8:00 AM to 5:00 PM) until April 06, 2020 at 9:00 AM, Philippine Standard Time from the address below and upon payment of the applicable fee for the Bidding Documents in the amount of Twenty Five Thousand Pesos (PHP 25,000.00).

It may also be downloaded free of charge from the website of the OMECO <u>site.omeco.com.ph/Pbac</u>, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of bids.

6. The OMECO will hold a Pre-Bid Conference on March 25, 2020, Wednesday at 10:00 AM, Philippine Standard Time at the OMECO Multi-Purpose Hall, OMECO Main Office, M.H. Del Pilar St., Barangay Poblacion VI, San Jose, Occidental Mindoro, which shall be open to prospective bidders.

Bidders are encouraged to attend the pre-bid conference to ensure that they fully understand the Procuring Entity's requirements. Non-attendance of the Bidder will in no way prejudice its bid, however, the Bidder is expected to know the changes and/or amendments to the Bidding Documents as recorded in the minutes of the pre-bid conference and the Supplemental/Bid Bulletin.

7. Bids must be duly received by the BAC Secretariat at the address below on or before April 06, 2020, Monday at 9:00 AM, Philippine Standard Time. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.

Bid opening shall be on April 06, 2020, Monday at 10:00 AM, Philippine Standard Time at OMECO Multi-Purpose Hall, OMECO Main Office, M.H. Del Pilar St., Barangay Poblacion VI, San Jose, Occidental Mindoro. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address stated. Late bids shall not be accepted.

- 8. OMECO reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
