A video conferencing meeting ID number will be provided to the bidders.


The bidding documents may be submitted through electronic mail or facsimile subject to the submission of the printed copies, provided that the **online submission of bids thru email is received on or before the scheduled date and time of the Opening of Bids** and that **the bidder must send the actual bid documents thru courier services, the tracking receipt should also be sent as an attachment to the email or a separate email on or before the scheduled date and time of Opening of Bids.**

The Bids and Awards Committee will conduct a COMPETITIVE BIDDING using a non-discretionary "pass/fail" criterion as specified in NEA Memorandum 2017-019 otherwise known as "Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives."
