

- Pre-bid Conference - August 4, 2020 (1:00 PM)
- Opening of Bids - August 17, 2020 (9:00 AM)
- Notice of Award - 7 days from the date of confirmation of the Lowest Calculated & Responsive Bid
- Contract Preparation & Signing - Within 5 working days after issuance of Notice of Award
