3. The Pre-Bid Conference shall be open to all interested parties; however, only those who have purchased the Bidding Documents before the start of the conference are qualified to participate the bidding.
4. Physical presence of the bidders during the pre bid conference and opening of bids is not required due to covid 19 pandemic, however interested bidders may opt to joined the conference via zoom.
5. Submission of bid proposal can be made through email or courier before the scheduled opening of bids.

Opening of Bids will be conducted through simplified bidding procedures (sealed canvass) as specified in the Alternative Modes of Procurement in the NEA Memorandum 2017-019 otherwise known as the "Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives IRR-RA10531 (2017)."
