Interested parties shall submit their "Letter of Intent" and must comply the accreditation requirements. Deadline of accreditation will be on **September 7, 2020**. There is a non-refundable accreditation fee of FIVE THOUSAND PESOS that is valid for one (1) year.

The complete set of Eligibility Requirements and Bidding Documents maybe purchased by interested bidders upon payment of a non-refundable fee **as stated above** from the Bids and Awards Committee Secretariat.

Only those bidders who have purchased the Bidding Documents are qualified to participate during the pre-bid conference where their presence is MANDATORY. Due to COVID-19 pandemic, the attendance for both pre-bid and opening of bids through video conference via Zoom link will be applicable.
