
- Bidding is open to all interested bidders, subject to the conditions for eligibility provided in the IRR of RA 9184 and RA 10531.
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act" and in the Revised Implementing Rules and Regulations (IRR) of Republic Act 10531. Bids received in excess of the ABC shall be automatically rejected in bid opening.
- Bidders should have successfully completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the above project. The description of an eligible bidder is contained in the Bidding Documents and Instructions to Bidders.
- A valid PCAB License (Philippine Contractors' Accreditation Board) is required with size range **Small B** and License Category **C & D** specialty – Electrical work for Lot 8, 11, 12, 13 & 14.
- Interested bidders should have a Tax clearance per Executive Order 398, Series of 2005, as finally reviewed and approved by the BIR, for a stock corporation must secure a General Information Sheet (GIS) – Securities and Exchange Commission with current updated Certificate of Good Standing, must be registered under the Philippine Government Electronic Procurement System (PhilGEPS).
- Bids shall be accompanied by a bid security payable to the procuring entity as guarantee that the successful bidder shall enter into contract from receipt of the Notice of Award, in the form of validated bank deposit slip amounting to 2% of the Approved Budget of the Contract. Failure to enclose the required bid security in the form and amount prescribed herein shall automatically disqualify the bid concerned.
- A compulsory attendance during the Pre-Bid Conference is hereby enjoined. Only those who have purchased the Bidding Documents shall be allowed to participate in the pre-bid conference and raise or submit written queries or clarifications.
- The Scope of work and technical specifications are contained in the Bidding Documents to be provided to all interested bidders upon application addressed to the Chairman, Bids and Awards Committee, COTELCO, Manubuan, Matalam, Cotabato.


