This Bid Bulletin No. 03, Series of 2020 dated 9 October 2020 is hereby issued to amend and clarify some provisions in the Bidding Documents for the Supply of Labor, Equipment and Materials for the Installation and Commissioning of Connection Point Protection, and Supply of Equipment for Temporary Power Transformer at San Jose Substation.

I. AMENDMENTS/CLARIFICATIONS TO THE BIDDING DOCUMENTS

SECTION	QUESTIONS AND CLARIFICATIONS RAISED DURING THE PRE-BID CONFERENCE	AMENDMENTS/ CLARIFICATIONS
ITB Clause 6.3 and ITB Clause 11.1(a)(vii)	One of the Bidders asked if the Committee could provide them a Certificate of Acceptance to visit the site.	Due to the limited and travel restrictions issued by the authority, the Committee hereby waved the provision on the site inspection that "the Bidder shall be deemed to have inspected the site", and "the Bidder shall secure Certificate of Site Inspection (CSI) from OMECO Technical Services Department. Non-submission of the said CSI will constitute grounds for disqualification". Also, the Committee hereby excluded from the Eligibility Documents the Certificate of Site Inspection (CSI) from OMECO TSD. In addition, the Committee attached herewith the pictures of the site and the coordinates for reference of Bidders.
ITB Clause 11.1 (a)(iii) and 11.1 (a)(iv)	The BAC Chairman raised that the ITB Clause 11.1 (a)(iii) and ITB Clause 11.1 (a)(iv) are the same.	The Committee hereby amended the ITB Clause 11.1 (a)(iii) and (iv) to BIR Certificate of Registration (BIR Form No. 2303).

This Bid Bulletin No. 03, Series of 2020 shall form part of the Bidding Documents. Any provisions in the Bidding Documents inconsistent herewith is hereby amended, modified and superseded accordingly.






