To qualify, interested bidders must submit electronic copy stamped with certified true copy in case of photocopied documents such as but not limited to: Company profile: Notarized statement in matrix form of all ongoing and completed government and private contracts (supported with purchase orders, job orders, etc.) including contracts awarded but not yet started, if any (**for the last five years**). Statement identifying the bidder's single largest completed contract similar to the contract to be bid within the relevant period as provided in the bidding documents with a value of at least 50% of the ABC (supported w/ contract, cert. of completion, project cost & cert. of acceptance), Copy of By-laws, Notarized statement of availability of key personnel and equipment, Notarized statement that prospective bidder is not blacklisted by any government or non-government agency; DTI Business Name registration or SEC registration certificate; Audited Financial Statements stamped received by the BIR for the immediately preceding year; Certificate of BIR Registration; Valid PCAB License Specialize in Electrical Works; Valid and current Mayor's Permit and Taxpayer's Identification Number.
