Interested parties shall submit their " Letter of Intent" and must comply the accreditation requirements. Deadline of accreditation will be on **November 3, 2020**. There is a non-refundable accreditation fee of FIVE THOUSAND PESOS that is valid for one (1) year.

Only those bidders who have purchased the Bidding Documents are qualified to participate during the pre-bid conference where their presence is MANDATORY. However, due to COVID-19 pandemic, the attendance for both pre-bid and opening of bids will be through video conference via Zoom link.
