Bidders should note of the following:

- Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as provided in RA 10531 and its IRR; and ANECO Online Procurement Policy as approved by NEA
- Cooperative will only accept bids from those bidders that paid the **non-refundable** fee for the Bidding Documents.
- Bidders or authorized representative/s who failed to attend the pre-bid conference or failed to submit waiver of rights to participate in the pre-bid conference will not be allowed to participate in the bidding.
- Bidders or authorized representative/s shall be required to present before ANECO security guard a **Negative** Rapid Antibody Test or RT-PCR Test Results having a seven (7) day validity period and submit copy to the BAC secretariat upon entering the bidding venue.
- The following period of delivery shall be observed:
 - For Lot No. 1, 3, 4, and 5 - Fifty percent (50%) delivery within forty-five (45) days from receipt of Notice to Proceed and full delivery within sixty (60) days from receipt of Notice to Proceed.
 - For Lot No. 2 - Forty-five (45) days from the receipt of Notice to Proceed for all Steel Poles with the height of thirty-five (35) feet and below. Sixty (60) days from the receipt of Notice to Proceed for all Steel Poles with the height of 40 feet to 70 feet
