The Antique Electric Cooperative, Inc. (ANTECO), thru its Procurement, Bids and Award Committee (PBAC), invites interested bidders/suppliers to bid for the **design, supply, delivery, installation, testing and commissioning of major substation equipment for the uprating of Culasi Substation from 5 MVA to 10 MVA** with an **Approved Budget Cost (ABC) of Sixteen Million Five Hundred Nineteen Thousand Eight Hundred Sixty One Pesos (Php 16,519,861.00)**. The fund will be from the ANTECO internally generated fund. The project should be delivered in not more than thirty (30) calendar days from the issuance of Notice to Proceed.
