Each bid shall be accompanied by a Bid Security equivalent to two percent (2%) of the total bid in the form of Bank draft/Guarantee or irrevocable letter of credit issued by a Universal or Commercial Bank as guarantee that the successful bidder shall enter into a contract from the Notice of Award and Notice to Proceed. Late Bids shall not be accepted.
