Invitation to apply for accreditation and to submit quotation for the "Supply of Labor and Materials for the Construction of Pile Supported Pole at Tagumpay/Lagnas River"

#### OMECO PAP No. BAC20-010

- 1. The Occidental Mindoro Electric Cooperative, Inc., (OMECO) through the approved Reinvestment Fund for Sustainable CAPEX (RFSC) intends to apply the sum of Seven Hundred Seventy-Eight Thousand Forty-Seven Pesos & 75/100 (PHP 778,047.75) being the Approved Budget for the Contract (ABC) to payments under the contract of Supply of Labor and Materials for the Construction of Pile Supported Pole at Tagumpay/Lagnas River. Quotations received in excess of the ABC shall be automatically rejected at the Opening of Sealed Canvass.
- 2. OMECO now invites Suppliers for the Supply of Labor and Materials for the Construction of Pile Supported Pole at Tagumpay/Lagnas River. Completion of the Works is required within Thirty (30) Calendar Days from receipt of Notice to Proceed (NTP). The description of an eligible bidder is contained in the Sealed Canvass Documents, particularly, in the Terms of Reference.
- 3. Bidding will be conducted through Sealed Canvass using a non-discretionary "pass/fail" criterion. Bidding is open to all OMECO's Accredited and Non-Accredited Suppliers, provided that Non-Accredited Suppliers must submit required accreditation documents listed in the **TOR Clause 9.7.2(a)**.
- 4. Sealed Canvass is restricted to Filipino citizens/sole proprietorships, cooperatives and partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 5. Interested Suppliers may obtain further information from OMECO Bids and Awards Committee (OMECO BAC) at the contact given below from 8:00 AM to 5:00 PM (office hours), Monday to Friday (except Holidays).
- 6. A complete set of Sealed Canvass Documents may be acquired by Interested Accredited Suppliers from *November 9, 2020 until December 2, 2020 at 2:00 PM* from the address below.
