

INVITATION TO BID
FOR THE REBIDDING OF SECURITY SERVICES FOR CAMARINES

1. The **Camarines Sur I Electric Cooperative, Inc. (CASURECO I)**, through its **General Fund** intends to apply the total sum of **Seven Million Six Hundred Forty Three Thousand Eighty Six Pesos and Sixteen Centavos (Php7,643,086.16)** being the **Approved Budget for the Contract (ABC)** for the **Rebidding of Security Services for CASURECO 1 /ITBN#CAS1-2021 SS**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. CASURECO I now invites bids for **Security Services for CASURECO** with an **ABC of Php 7, 643,086.16**.

Bidders should have completed a contract similar to the Project at least three (3) years within the last five (5) years prior to the bidding. The description of an eligible bidder is contained in the Bidding Documents, particularly on Item 3, Page 5, Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the NEA Memorandum No. 2017 – 019 Revised Guidelines and Simplified Bidding Procedures for Electric Cooperatives IRR-R.A. 10531 (2017).

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

- Interested bidders may obtain further information from BAC Secretariat, Annabelle R. Paglinawan/ Edlyn Pardiñas and inspect and acquire the Bidding Documents at the address given below during office hours, Monday to Friday (except Holiday's) before the opening of Bids.

A complete set of Bidding Documents may be purchased by the **new** interested Bidders from the address below upon payment of a **non-refundable fee of Ten Thousand Pesos (Php 10,000.00) and Five Thousand Pesos (Php 5,000.00)** to Bidder/s who previously purchased the bidding documents. However, only Bidders who have paid the nonrefundable fee for the Bidding Documents can participate in the bidding.

- CASURECO 1 will hold a Pre-Bid Conference and Opening of Bids (on the date, time and venue stated above), which shall be open only to all interested parties who have purchased the Bidding Documents.

- Bids must be delivered to the address below on or before (date and time stated above). All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in Item 13, Page 12 under Instruction to the Bidders.


Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
