A complete set of Bidding Documents may be purchased by interested Bidders (see above schedule) and upon payment of a non-refundable fee for the bidding Documents from Monday to Friday, 8:00 am to 5:00 pm.
- Qualified bidders are required to attend the Pre-Bid Conference via video conferencing and face to face meeting and only those who have purchased the Bidding Documents are allowed to participate.
- NORSAMELCO reserves the right to accept or reject any bid, to annul the bidding process and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
