Due to pandemic, Covid-19, the Pre-bid Conference and the Submission and Opening of Bids shall be conducted through a virtual meeting which will be held at PALECO BAC Conference Room, Main Office, Kilometer 3.35 North National Highway, Bgy. Tiniguiban, Puerto Princesa City in the below stated schedule:

Pre bid conference, and deadline for the submission/opening of bids shall be in PALECO BAC Room, at 9:00 a.m. on November 23, 2020, and December 14, 2020, respectively. Bid documents will be available to prospective bidders starting November 16, 2020 until 3:00 p.m. of December 9, 2020, upon payment of a non- refundable registration fee indicated above to the PALECO teller or through bank online payment. All bids must be accompanied by a bid security in form of cash, cashier/manager's check in the amount equivalent to two percent (2%) of the Approved Budget Cost.

The above project, funded out of the national government subsidy for Sitio Electrification Program (2020 SEP GAA) shall be completed within the contract duration upon receipt of the Notice to Proceed.

Bidders are hereby expected to conduct due diligence prior to the pre-bid conference on the above stated projects.

PALECO hereby reserves the right to reject any or all bids, to waive any minor defects or infirmities therein, and to accept such bids as may be deemed advantageous to PALECO.
