Invitation to Bid No. 2020-02 (RE-ADVERTISEMENT)

CEBU III ELECTRIC COOPERATIVE, INC. (CEBECO III), through its **Bids and Awards Committee (BAC)**, hereby invites all interested manufacturers, suppliers, dealers, contractors and authorized franchised dealers to submit their respective bids for the procurement, supply and delivery of the following materials/equipment for “CEBECO III’s President Rodrigo Roa Duterte Sitio Electrification Program (SEP) of Eighteen (18) Sitios under the 2020 General Appropriations Act” as approved by the National Electrification Administration as described hereunder:

The submitted documents of each bidder shall be examined and checked for completeness against a checklist of eligibility requirements to ascertain that they are all present using a non-discretionary “pass/fail” criterion.

Due to the ongoing COVID-19 Pandemic, all Bids shall be opened and read in the presence of Bidders or their duly authorized representatives, through Virtual Conferencing. Bidders shall be required to post a Bid Security in the amount equivalent to 2% of the ABC. Only those bidders who have bought the bidding documents shall be allowed to attend and participate during the **Mandatory Pre-bid conference** via video/online conferencing using Zoom Meetings. Pre-registration shall be required for all interested bidders to access the video conferences via Zoom Meeting in order to participate in the procurement activities as scheduled. Once registered, the BAC Secretariat will send a confirmation email for the step by step process for the scheduled bidding activities.

The prospective bidder must have completed within 5 years from the date of bid opening an SLCC that is similar to the contract to be bid, and whose value, adjusted to current prices using the Philippine Statistics Authority (PSA) consumer price indices, must be at least fifty percent (50%) of the ABC.
