

1. DTI Business name registration or SEC registration certificate;
2. Valid and Current Mayor's permit/municipal license;
3. Tax payer's identification number;
4. BIR Value Added Tax registration;
5. A certificate that the supplier/contractor is not blacklisted or banned from bidding by the government or any of its agencies and private corporations or electric cooperatives;
6. Compliance with EO #398:
 - a. Proof of VAT payment for the past six months, and
 - b. Tax clearance from BIR for the last two quarters.
7. On-going, completed, or awarded contract not yet started within the relevant period specifying the following:
 - a. Name of the contract,
 - b. Date of the contract,
 - c. Amount of contract and value of outstanding contracts,
 - d. Date of Delivery and
 - e. End-user's acceptance if completed.

Please be advised, however, that there is a Non-refundable Accreditation Fee of **Two Thousand Five Hundred Pesos (Php2, 500.00)** that is valid for one (1) year. Likewise, accredited bidders shall secure the bidding documents before the pre-bid conference.
