

- The Bid Documents may be acquired by the interested bidder/s upon payment of a non-refundable fee of the Bidding Documents. The bidder must email to the BAC the scanned copy of the Deposit Slip for the Bidding Documents Fee.
- Bidding Documents will be emailed to the bidders via email address of the bidder declared in the Letter of Intent.
- Only Bidders who have paid the Bidding Documents Fee shall be allowed to join the Online Pre-Bid Conference. Non-attendance in the Pre-Bid Conference shall be deemed a waiver on the part of the absent Bidder to question any matter that was taken up and decided during the Pre-Bid Conference.
- A Security Bond of 2% in the form of cash, cashier's/manager's check, bank draft or bank guarantee is required to be posted.
- ZAMCELCO reserves the right to reject any or all bids, waive any formality or technicality therein, accept any bid deemed most advantageous to ZAMCELCO, or annul the bidding process and not award the contract at any time prior to contract award without incurring any liability to any bidder or party.
