Invitation to Apply for Eligibility and to Bid for the

"Procurement of Boom Truck"

1. The Tablas Island Electric Cooperative, Inc.(TIELCO) through the approved CAPEX 2016-2021 intends to procure the following item through a commodity loan as follows:

being the Approved Budget of the aforesaid item. Bids received in excess of the ABC for the said item shall be automatically rejected at the bid opening.

- 2. TIELCO now invites bids for the **Procurement of Boom Truck**. Delivery of the goods is required within thirty (30) calendar days from receipt of the Notice to Proceed (NTP) and Purchase Order (PO) and shall be delivered to TIELCO Main Office, Dapawan, Odiongan, Romblon. The description of the eligible bidder is contained in the Bidding Documents, particularly, in the Instruction to Bidders.
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act" and 2017 Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives Implementing Rules and Regulations (IRR) of Republic Act (RA) 10531.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- 4. Interested bidders may obtain further information from TIELCO Bids and Awards Committee (BAC) and inspect the Bidding Documents at the address given below or via BAC official email address tielco-pbac@yahoo.com during Monday to Friday from 8:00 AM to 5:00 PM, Philippine Standard Time, except Holidays.
- 5. A complete set of Bidding Documents may be acquired by interested bidders from December 7 (office hours 8:00 AM to 5:00 PM) until December 11, 2020 at 12:00 NN, Philippine Standard Time from the address below and upon payment of the applicable fee for the Bidding Documents in the amount of Ten Thousand pesos (PHP 10.000.00).

Due to travel restrictions, Bidders may also acquire the electronic copy of the complete set of the Bidding Documents via official email address of BAC <u>tielco_pbac@yahoo.com</u>, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of bids.

6. TIELCO will hold a Pre-Bid Conference on December 11, 2020 at 1:00 PM, Philippine Standard Time at the TIELCO Main Office, Dapawan, Odiongan, Romblon, which shall be open to prospective bidders.

Due to the uncertainties brought by the current public health crisis (COVID-19), the BAC will conduct the prebid conference virtually via ZOOM.

Bidders are encouraged to attend the pre-bid conference to ensure that they fully understand the Procuring entity's requirement. Non-attendance of the Bidder will in no way prejudice its bid, however, the Bidder is expected to know the changes and/or amendments to the Bidding Documents as recorded in the minutes of the pre-bid conference and the Supplemental/ Bid Bulletin.

7. Bids must be duly received by the BAC Secretariat at the address below on or before December 28, 2020, at 9:00 AM, Philippine Standard Time. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.

Bid Opening shall be on December 28, 2020 at 9:00 AM, Philippine Standard Time at TIELCO Main Office, Dapawan, Odiongan, Romblon. Bids will be opened in the presence of the bidder's representatives who attend at the address stated or via ZOOM. Late bids shall not be accepted.

- 8. TIELCO reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
