The complete set of Eligibility Requirements and Bidding Documents maybe purchased by interested bidders upon payment of a non-refundable fee **as stated above** from the Bids and Awards Committee Secretariat. The interested bidder may opt to deposit the payment at the BATELEC I Account No. 0901-0057-53, BPI Balayan branch. The copy of deposit slip must be sent to batelec1bac@yahoo.com and the bid documents will be sent in pdf form.
3. The bidding activities shall be held on the above schedules at the Training Room, BATELEC I H.Q., Km 116 National Highway, Calaca, Batangas.
4. The Pre-Bid Conference shall be **open only to interested bidders who bought the Bidding Documents**.

The interested bidders who will attend the pre-bid conference and opening of bids must secure a Medical Certificate stating that the bearer is cleared from "COVID-19" issued by their respective RHU. Maximum of two (2) representatives per interested bidders are allowed to attend in the said bidding activities.

BATELEC I hereby reserves the absolute right to accept or reject any or all bids, to waive any formality therein and to accept such bid as maybe considered advantageous to the Cooperative or annul the bidding process and not award the contract at any time prior to the contract award without incurring any liability to any bidder or party.
