

Bidders are required to attend a pre-bid conference (via zoom video conference) to be conducted at QUEZELCO I Boardroom on January 11, 2021 at 9:00AM.

All bids submitted must be accompanied by a bid security in cash or manager's check equivalent to 2% of the Approved Budget for the Projects to be Bid.
