Invitation to Apply for Eligibility and to Bid for the “Supply of Labor and Materials for the Relocation of Poles and Dismantling/Removal, and Disposal of affected facility due to Road Widening Projects of DPWH”

1. The **Occidental Mindoro Electric Cooperative, Inc., (OMECO)** through the DPWH Fund (F.Y. 2019 RA 11260 Continuing Reg. 2019 CONTINUING 200000100323000 SR2020-06-005160 dated June 10, 2020 RC:18-001-01-00000-PREXC-12-ROW-Right-of-Way and OMECO’s Reinvestment Fund for Sustainable CAPEX intends to apply the sum of **Thirty-One Million Seven Hundred Eighty-Six Thousand Eight Hundred Sixty-Six Pesos & 43/100 (PHP 31,786,866.43)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Supply of Labor and Materials for the Relocation of Poles and Dismantling/Removal, and Disposal of affected facility due to Road Widening Projects of DPWH (OMECO PAP No. BAC20-011)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. OMECO now invites bids for the **Supply of Labor and Materials for the Relocation of Poles and Dismantling/Removal, and Disposal of affected facility due to Road Widening Projects of DPWH (OMECO PAP No. BAC20-011)**. Completion of the Works is required within **Seventy-Eight (78) Calendar Days** from receipt of Notice to Proceed (NTP). The description of an eligible bidder is contained in the Bidding Documents, particularly, in the Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA 9184), otherwise known as the “Government Procurement Reform Act”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives and partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from OMECO – Bids and Awards Committee (OMECO-BAC) and inspect the Bidding Documents at the address given below during **Monday to Friday from 8:00 AM to 5:00 PM (except Holidays)**.
5. A complete set of Bidding Documents may be acquired by interested bidders from **December 18, 2020 (office hours 8:00 AM to 5:00 PM) until January 11, 2021 at 1:00 PM** from the address below and upon payment of the applicable fee for the Bidding Documents in the amount of **Twenty Five Thousand Pesos (PHP 25,000.00)**.

It may also be downloaded free of charge from the website of the OMECO www.omeco.com.ph/Bac/Default, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of bids. However, due to travel restrictions, Bidders may also acquire the electronic copy of the complete set of Bidding Documents via official email address of BAC omeco2018bac@gmail.com.

6. The OMECO will hold a Pre-Bid Conference on **December 28, 2020, Monday at 2:00 PM** at the OMECO Main Office, Barangay Poblacion VI, San Jose, Occidental Mindoro, which shall be open to Prospective Bidders.

Due to the uncertainties brought by the current public health crisis (COVID-19), the BAC will conduct the pre-bid conference virtually via ZOOM.

Bidders are encouraged to attend the pre-bid conference to ensure that they fully understand the Procuring Entity's requirements. Non-attendance of the Bidder will in no way prejudice its bid; however, the Bidder is expected to know the changes and/or amendments to the Bidding Documents as recorded in the minutes of the pre-bid conference and the Supplemental/Bid Bulletin.

7. Bids must be duly received by the BAC Secretariat at the address below on or before **January 11, 2021, Monday at 1:00 PM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **January 11, 2021, Monday at 2:00 PM** at OMECO Main Office, Barangay Poblacion VI, San Jose, Occidental Mindoro. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address stated or virtually via ZOOM. Late bids shall not be accepted.

8. The OMECO reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
