Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in NEA Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives as amended and applicable rules of RA 9184.

BILECO through the BILECO BAC reserves the right to reject any or all bids, declare failure of bidding, to waive any minor defects or informalities therein and to accept any or all offers as may be considered most responsive and advantageous to the procuring entity.
