Invitation to Apply for Eligibility and to Bid for the "Supply and Delivery of Distribution Transformer and Protective Equipment"

OMEKO PAP No. BAC21-001

1. The Occidental Mindoro Electric Cooperative, Inc., (OMEKO) through the approved General Fund intends to apply the sum of:

Distribution Transformer and Protective Equipment	6,474,000.00	10,000.00

being the Approved Budget for the Contract (ABC) to payments under the contract of Bids received in excess of the ABC shall be automatically rejected at the bid opening.

2. OMEKO now invites bids for the **Supply and Delivery of Distribution Transformer and Protective Equipment**. Delivery of the Goods is required within **thirty (30) calendar days** from receipt of the Notice to Proceed (NTP) and Purchase Order (PO), and shall be delivered to OMEKO Main Office, M.H. Del Pilar St., Barangay Poblacion VI, San Jose, Occidental Mindoro. The description of an eligible bidder is contained in the Bidding Documents, particularly, in the Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act" and 2017 Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives Implementing Rules and Regulations (IRR) of Republic Act (RA) 10531.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from OMEKO – Bids and Awards Committee (OMEKO-BAC) and inspect the Bidding Documents at the address given below or via BAC official email address omeco2018bac@gmail.com during **Monday to Friday from 8:00 AM to 5:00 PM, Philippine Standard Time, except Holidays**.
5. A complete set of Bidding Documents may be acquired by interested bidders from **January 19, 2021 (office hours 8:00 AM to 5:00 PM) until February 8, 2021 at 9:00 AM**,

Philippine Standard Time from the address below and upon payment of the applicable fee for the Bidding Documents in the amount of **Ten Thousand Pesos (PHP 10,000.00)**.

Due to travel restrictions and unavailability of OMECO website, Bidders may also acquire the electronic copy of the complete set of Bidding Documents via official email address of BAC omeco2018bac@gmail.com, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of bids.

- The OMECO will hold a Pre-Bid Conference on **January 25, 2021, Monday at 10:00 AM, Philippine Standard Time** at the OMECO Main Office, Barangay Poblacion VI, San Jose, Occidental Mindoro, which shall be open to prospective bidders.

Due to the uncertainties brought by the current public health crisis (COVID-19), the BAC will conduct the pre-bid conference virtually via ZOOM.

Bidders are encouraged to attend the pre-bid conference to ensure that they fully understand the Procuring Entity's requirements. Non-attendance of the Bidder will in no way prejudice its bid, however, the Bidder is expected to know the changes and/or amendments to the Bidding Documents as recorded in the minutes of the pre-bid conference and the Supplemental/Bid Bulletin.





Bids will be opened in the presence of the bidders' representatives who choose to attend at the address stated or via ZOOM. Late bids shall not be accepted.

- OMECO reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
