The Pre-bid conference will be held at BOHOL II ELECTRIC COOPERATIVE, INC. Barangay Cantagay, Jagna, Bohol. Only those who have purchased the bidding documents shall be allowed to participate the pre-bid conference.

The Eligibility Check and Preliminary Examination of Bids shall use non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulation of Republic Act 9184 otherwise known as Government Procurement Act. Post qualification of the lowest calculated bid shall be conducted.

Due to the threats of COVID -19 and in compliance of the safety protocols to combat the current pandemic, The Pre-Bid conference via videoconference is permitted. Bid submission may be done through any electronic means available to the BAC or through any authorized courier/ representative. BOHECO II adopts the Government Procurement Policy Board (GPPB) resolution 09-20212 on measure to conduct procurement activities during the state of calamity.

Sealed bids must be submitted to the BAC Secretariat on or before the opening of bid scheduled above. Bids will be opened in the presence of the bidders' authorized representative. Late bids shall not be accepted.

The BOHOL II, reserves the right to accept or reject any bid to annul the bidding process and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
