




## INVITATION TO BID

1. The Bukidnon Second Electric Cooperative, Inc. (BUSECO) through its Bids and Awards Committee (BAC) invites interested bidders to apply to bid for the following projects:

3. Due to the ongoing COVID-19 Pandemic, the Bidding Proper and opening of bids shall be on **March 24-25, 2021 at 10 o'clock in the morning**, Philippine Standard Time (PST), through *Virtual Conferencing*.
4. Bid documents can be purchased at the BUSECO Main Office, Tankulan, Manolo Fortich, Bukidnon from March 3, 2021 to March 12, 2021 prior to the start of the pre-bid conference.
5. Only interested bidders (and/or authorized representative/s) are allowed to participate in the pre-bid conference upon payment of the non-refundable fee of Fifty Thousand Pesos (PhP 50,000.00) before 10:00 am Philippine Standard Time (PST) of the said date.
6. The **PRE-BID CONFERENCE** shall be done through Virtual Conferencing on **March 12, 2021** at 10:00 o'clock in the morning (PST). Bidder who failed to attend the Pre-Bid Conference, as scheduled, can still participate during the Bidding proper. However, it will mean a waiver of their right to question any provision of the Bidding Package.
7. Project delivery or completion shall depend on the items to be bided.
