Electronic copy of bids must be received by the BAC Secretariat thru email prior to the date and time of Bid Opening indicated above, at which date and time the eligibility requirements, technical and financial proposals will be opened and read in the presence of bidders or their authorized representatives.

Sealed bids (hard copies) must be sent at least one (1) day before the bid opening date and the official receipt of the courier must be submitted thru email of the BAC Secretariat before the online opening of bids.

The Online Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in NEA Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives IRR and applicable rules of **RA 10531**.

BILECO through the BILECO BAC reserves the right to reject any or all bids, declare failure of bidding, to waive any minor defects or informalities therein and to accept any or all offers as may be considered most responsive and advantageous to the procuring entity.
