All Bids shall be opened and read in the presence of Bidders or their duly authorized representatives. Bidders shall be required to put up a Bid Security in the amount equivalent to 2% of the ABC. The Bid Security shall be in the form of cash or manager's check and submitted together with their Bids. Only those bidders who have bought the bidding documents shall be allowed to attend or participate during the pre-bid conference where attendance is **MANDATORY**. Due to the COVID-19 pandemic, the attendance for both the Pre-bid Conference and Bid Opening through video conference via zoom link will be applicable. Zoom ID and password will be sent to your provided email address. However, for bidder/s who decide to physically attend both in Pre-bid Conference and Bid Opening, they should notify the BAC Secretariat at least a day ahead of the designated dates for administrative preparation purposes.
