The Bid Security shall be in the form of cash or manager's check and submitted together with their Bids. Only those bidders who have bought the bidding documents shall be allowed to attend or participate during the pre-bid conference where **attendance is MANDATORY**. Due to the COVID-19 pandemic, the attendance for both the Pre-bid Conference and Bid Opening through video conference via zoom link will be applicable.
