INVITATION TO APPLY FOR ELIGIBILITY AND TO BID FOR THE SUPPLY AND DELIVERY OF DEMAND METERS AND ACCESSORIES INTENDED FOR NEW CONNECTIONS AND REHABILITATION OF BIG LOAD CONNECTIONS TO ZAMSURECO-I

1. The Zamboanga del Sur I Electric Cooperative, Inc. (ZAMSURECO-I) now invites suppliers/bidders to apply for eligibility and to bid for the Supply and Delivery of Kwh Demand Meters and Accessories intended for New Connection and rehabilitation of Big load connections, *with the* Approved Budget for the Contract (ABC) of PhP 18,441,000.00 for the entire lot, VAT inclusive, as follows;



2. The source of fund is coming from the RFSC/General fund of the Cooperative. Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. The delivery period shall be within a period of 60 to 90 days, starting from the receipt of Purchase Order and Notice to Proceed. The terms of payments shall be within thirty (30) days from delivery and acceptance of the items put to bid, with details as follows:
- o First Delivery: June 15, 2021 - 40% of the total qty
 - o Second Delivery: July 15, 2021 - 30% of the total qty
 - o Third Delivery: August 15, 2021 - 30% of the total qty
4. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the NEA's Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives. All proposals shall be evaluated based on the responsiveness of the Bidder's offer to the Contract put out to bid and shall be subject to Post-qualification.
5. The items/materials/project's scope and technical requirements details, guidelines, terms and conditions are outlined in the Bid Documents which shall be provided to all applicants/bidders upon payment of Non-Refundable fee of Twenty Five Thousand Pesos (PhP 25,000.00).
