 The Occidental Mindoro Electric Cooperative, Inc., (OMECO) through the Reinvestment Fund for Sustainable CAPEX (RFSC) intends to apply the sum of:

being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at the bid opening.

- OMECO now invites bids for the Supply and Delivery of Hardware and Materials for Customer Connection Maintenance 2021 and Upgrading and Maintenance for Semi Annual Requirements: Lot I kWh Meters, Lot II Hardware and Materials and Lot III Plastic kWh Meter Seal. Delivery of the Goods is required within thirty (30) calendar days from receipt of the Notice to Proceed (NTP) and Purchase Order (PO), and shall be delivered to OMECO Main Office, M.H. Del Pilar St., Barangay Poblacion VI, San Jose, Occidental Mindoro. The description of an eligible bidder is contained in the Bidding Documents, particularly, in the Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2017 Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives Implementing Rules and Regulations (IRR) of Republic Act (RA) 10531.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- 4. Del Pilar St., Barangay Poblacion VI, San Jose, Occidental Mindoro. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address stated. Late bids shall not be accepted.

- OMECO reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives IRR - RA 10531 (2017), without thereby incurring any liability to the affected bidder or bidders.
