2. Interested bidders to participate in the bidding must submit their Letter of Intent to the ZBAC indicating thereto the lot to be participated and the official email address and contact no. to whom all transactions pertaining to the bidding will be communicated.
3. Bidding documents may be acquired by the interested bidder/s upon payment of a non-refundable fee as indicated on the table above. The bidder must email to the BAC the scanned copy of the deposit slip for the bidding documents fee.
4. Bidding documents will be sent to the bidders via email address of the bidder declared in the Letter of Intent.
5. Only Bidders who have paid the Bidding Documents Fee shall be allowed to join the Online Pre-Bid Conference. Non-attendance in the Pre-Bid Conference shall be deemed a waiver on the part of the absent Bidder to question any matter that was taken up and decided during the Pre-Bid Conference.
6. A Security Bond which is equivalent to two percent (2%) of the ABC is required to be posted.
7. ZAMCELCO reserves the right to reject any or all bids, waive any formality or technicality therein, accept any bid deemed most advantageous to the cooperative, or annul the bidding process and not award the contract at any time prior to contract award without incurring any liability to any bidder or party. Further, ZAMCELCO assumes no obligation to compensate any bidder for any loss or expense incurred in the preparation of the bid or participation in the bidding process.
