- Bidding is open to all interested bidders, subject to the conditions for eligibility provided in the IRR of RA 10531. It will be
 conducted through Open Competitive Bidding Procedures using a non-discretionary "pass/fail" criterion as specified in the
 Revised Implementing Rules and Regulations (IRR) of Republic Act 10531. Bids received in excess of the ABC shall be
 automatically rejected in the Bid Opening.
- 2. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project to be bid. The description of an eligible bidder is contained in the Bidding Documents and Instruction to Bidders.
- 3. Bids shall be accompanied by a bid security payable to the procuring entity as guarantee that the successful bidder shall enter into contract from receipt of the Notice of Award, in the form of validated bank deposit slip/fund transfer confirmation from the bank amounting to 2% of the Approved Budget of the Contract. Failure to enclose the required bid security in the form and amount prescribed herein shall automatically disqualify the bid concerned.
- 4. Only those who have purchased the Bidding Documents shall be allowed to participate in the pre-bid conference and raise or submit written queries or clarifications. A compulsory attendance during the Pre-Bid Conference is hereby enjoined.
- A valid PCAB License (Philippine Contractors' Accreditation Board) is required with size range Small B and License Category C & D specialty Electrical work for the Supply of Labor and Materials for the Construction of Lines (BAC Control No. 06-2021).
- The Scope of work and technical specifications are contained in the Bidding Documents to be provided to all interested bidders upon application addressed to the Chairman, Bids and Awards Committee, COTELCO, Manubuan, Matalam, Cotabato.
