However, bidding documents shall still be available for purchase by accredited suppliers after the pre-bidding conference. Deadline for purchase of bidding documents is 5 days before the bid opening date.

All interested bidders who are not yet accredited may submit application for accreditation subject to board approval prior to purchase of bidding documents and participation in the biddings.

Prospective bidders are required to have a stable internet connection during the conferences and the BAC shall not be liable for any unexpected disruption due to poor/unstable signal which may cause prospective bidders' inability to catch up with the conference. All Bid Proposals shall be accepted at the BAC Office two (2) hours before the scheduled bid opening conferences, otherwise, shall be disqualified.

BATELEC II reserves the right to accept or reject any and all bids, to declare failure of bidding, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder/s.
