Once payment is verified, the bid documents will be emailed to the interested bidders. Only those who have purchased the bid documents are qualified to participate in the bidding.

The bidding activities will be conducted on the above schedules and venue. Due to threats of COVID-19 and in compliance of the safety protocols issued by the local and provincial AITF, any bidder who cannot be physically present can attend through the video conferencing platform hosted by the Bids and Awards Committee. NORECO II adopted the Government Procurement Policy Board (GPPB) Resolution 09-2020 on measure to conduct procurement activities during the state of pandemic. A meeting ID number will be provided to the bidders.

The bidding documents may be submitted through electronic mail or facsimile subject to the submission of the printed copies, provided that the online submission of bids thru email is received on or before the scheduled date and time of the Opening of Bids and that the bidder must send the actual bid documents thru courier services, the tracking receipt should also be sent as an attachment to the email or a separate email on or before the scheduled date and time of Opening of Bids.

The Bids and Awards Committee will conduct a **COMPETITIVE BIDDING** using a non-discretionary “pass/fail” criterion as specified in NEA Memorandum 2017-019 otherwise known as “Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives.”

NORECO II reserves the right to reject any bid and all proposals, to declare failure of bidding, and to reject all bids prior to the awarding of contract without incurring any obligations to any bidder or bidders in the preparation and tender of their bids.
