- Bidding documents will be sent to the bidders via email address of the bidder declared in the Letter of Intent.
- 5. Only Bidders who have paid the Bidding Documents Fee shall be allowed to join the Online Pre-Bid Conference. Non-attendance in the Pre-Bid Conference shall be deemed a waiver on the part of the absent Bidder to question any matter that was taken up and decided during the Pre-Bid Conference.
- 6. A Security Bond which is equivalent to two percent (2%) of the FLOOR PRICE is required to be posted.
- 7. ZAMCELCO shall award the bidder with the highest offer and compliant to the bid requirements.
