- 5. LANECO will hold a Pre-Bid Conference (date and time stated above) which will be open to all interested parties who have purchased bidding documents. Attendees to the pre-bid conference are only the prospective bidders or their authorized representative (through a written authorization duly notarized).
- 6. Due to the threat of Covid-19, bidders have the option to come personally following the health protocols or join via ZOOM during the Pre-Bid Conference and Opening of Bids.

For Bidders who opt to join via ZOOM, they must confirm at least three (3) days before the Pre-Bid conference and Opening of Bids to the BAC Secretariat to facilitate the registration of participants and zoom details of the Bidding. Bidders should sign in one (1) hour before the start of meeting.
- 8. Bids must be submitted to the address below on or before (date and time stated above). All Bids must be accompanied by a bid security.
