Project 2: For Lot 1 the delivery of materials, mobilization, ROW Clearing, and substation construction shall be completed within Ninety (90) Calendar Days after issuance of Notice to Proceed and for Lots 2 & 3 the delivery of materials, mobilization, ROW Clearing and line construction shall be completed within Sixty (60) Calendar Days after issuance of Notice to Proceed.
