INVITATION TO APPLY FOR ELIGIBILITY AND TO BID BID NO. 2021-02

Rehab and Reroute of Toledo Feeder 3 from Luray to Mainggit Using 336.4 MCM Tree Wire

CEBU III ELECTRIC COOPERATIVE, INC. (CEBECO III) through its 2021 Capital Expenditure Budget, intends to apply the sum of Sixteen Million Six Hundred Twenty Thousand Two Hundred Sixteen Pesos and Seventy Three Centavos (P16,622,216.73), inclusive of all applicable taxes and fees, being the Approved Budget of the Contract (ABC) for the Rehab and Reroute of Toledo Feeder 3 from Luray to Mainggit, Using the 336.4 MCM Tree Wire.

CEBECO III now invites bids for the supply and delivery of materials and labor, to rehab and reroute the Toledo Feeder 3, using the 336.4 MCM Tree Wire from Luray to Mainggit. Completion of the work is required within 200 calendar days from receipt of Notice to Proceed.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Bid Document is strictly non-refundable and non-transferrable.
- 3. The prospective bidder must have completed within 5 years from the date of bid opening an SLCC that is similar to the contract to be bid, and whose value, adjusted to current prices using the National Electrification Administration (NEA) or the Philippine Statistics Authority (PSA) consumer price indices, must be at least fifty percent (50%) of the ABC.
- 4. Only those bidders who have purchased the Bidding Documents are qualified to participate during the MANDATORYPRE-BIDCONFERENCE.
