3. Prospective Bidders for Schedules I and II must possess a Philippine Contractors Accreditation Board (PCAB) licenses of atleast:

Payment shall be based on the Percentage Completion Report certified by MARELCO-TSD in accordance with the following scheme: For Schedules I & II: 15% for Mobilization Fee; 35% upon Accomplishment of 50%; 40% upon Accomplishment of 100% duly supported with Final Inspection of the MARELCO-TSD and 10% Retention shall be required and released only a year after completion of the project and after issuance of Certificate of Final Inspection by the National Electrification Administration (NEA). For Schedule III, payment shall be made within 30-60 days after completion of delivery and acceptance.
