Invitation to Apply for Eligibility and to Bid for the "Supply and Delivery of Labor and Materials for Rehab and Upgrading of Octopus Connections (13 CAPEX Project)"

OMEKO PAP No. BAC21-004

1. The Occidental Mindoro Electric Cooperative, Inc., (OMEKO) through the approved Reinvestment Fund for Sustainable Capex (RFSC) intends to apply the sum of:

PARTICULARS	ABC (PHP)	NON-REFUNDABLE BID FEES (PHP)
Rehab/Upgrading of Octopus Connection	6,093,727.50	10,000

being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at the bid opening.

2. The OMEKO now invites bids for the **Supply and Delivery of Labor and Materials for Rehab/Upgrading (13 CAPEX PROJECT)**. Completion of the Works is required within **Seventy (70) Calendar Days** including testing and commissioning reckoned from receipt of Notice to Proceed (NTP). The description of an eligible bidder is contained in the Bidding Documents, particularly, in the Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives and partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from OMEKO – Bids and Awards Committee (OMEKO-BAC) and inspect the Bidding Documents at the address given below during **Monday to Friday from 8:00 AM to 5:00 PM (except Holidays)**.
5. A complete set of Bidding Documents may be acquired by interested bidders from **October 21, 2021 (office hours 8:00 AM to 5:00 PM) until October 27, 2021 at 9:00 AM** from the address below and upon payment of the applicable fee for the Bidding Documents in the amount of **Ten Thousand Pesos (PhP 10,000.00)**.

Due to travel restrictions and unavailability of OMEKO website, Bidders may also acquire the electronic copy of the complete set of Bidding Documents via official e-mail address of BAC omeco2018bac@gmail.com, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of bids.

6. The OMEKO will hold a Pre-Bid Conference on **October 27, 2021, Wednesday at 10:00 AM** at the OMEKO Main Office, Barangay Poblacion VI, San Jose, Occidental Mindoro, which shall be open to prospective bidders.

Due to the uncertainties brought by the current public health crisis (COVID-19), the BAC will conduct the pre-bid conference virtually via ZOOM.

Attendees to the Pre-Bid conference are only the prospective bidders who have bought bid documents, or their authorized representative (duly notarized).

Bidders are encouraged to attend the pre-bid conference to ensure that they fully understand the Procuring Entity's requirements. Non-attendance of the Bidder will in no way prejudice its bid; however, the Bidder is expected to know the changes and/or amendments to the Bidding Documents as recorded in the minutes of the pre-bid conference and the Supplemental/Bid Bulletin.

7. Bids must be duly received by the BAC Secretariat at the address below on or before **November 8, 2021, Monday at 9:00 AM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **November 8, 2021, Monday at 10:00 AM** at OMEKO Main Office, Barangay Poblacion VI, San Jose, Occidental Mindoro. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address stated. Late bids shall not be accepted.

8. The OMEKO reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
