1. The **Occidental Mindoro Electric Cooperative, Inc., (OMECO)** through the approved General Fund intends to apply the sum of:

being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Quotations received in excess of the ABC shall be automatically rejected at the Opening of Sealed Canvass.

OMECO now invites Accredited Suppliers for the *Supply and Delivery of OMECO' OEER* is required within **Thirty (30) Calendar Days** from receipt of Notice to Proceed (NTP) and Purchase Order (PO) and shall be delivered in OMECO Main Office, M.H. Del Pilar St., Brgy. Poblacion VI, San Jose, Occidental Mindoro.
3. Bidding will be conducted through Sealed Canvass using a non-discretionary "pass/fail" criterion. Bidding is open to all OMECO's Accredited and Non-Accredited Suppliers, provided that Non-Accredited Suppliers must submit required accreditation documents listed in the **Accreditation Check List Requirement** as provided.
4. Request for Quotation (Sealed Canvass) is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
5. Interested Suppliers may obtain further information from OMECO – Bids and Awards Committee (OMECO – BAC) at the contact given below from **8:00 AM to 5:00 PM (office hours), Monday to Friday (except Holidays)**.
6. A complete set of Sealed Canvass Documents may be acquired by Interested Suppliers from **November 5, 2021 until November 25, 2021 at 9:00 AM** from the address below. It may also be downloaded free of charge from the website of OMECO www.omeco.com.ph/Bac/Default.
7. Quotations must be duly received by the BAC Secretariat at the address below on or before **November 25, 2021, Wednesday at 9:00 AM**.

8. Opening of Sealed Canvass shall be on **November 25, 2021, Wednesday at 10:00 AM** at OMECO Main Office, M.H. Del Pilar St., Brgy. Poblacion VI, San Jose, Occidental Mindoro. Late quotations shall not be accepted.




