Interested joint ventures and consortia shall possess the requisite special license at the time of the submission of bid documents in accordance with RA No. 4566 and its IRR.

Due to pandemic, Covid-19, the Pre-bid Conference and the Submission and Opening of Bids shall be conducted through a virtual meeting which will be held at PALECO BAC Conference Room, Main Office,

Office, Kilometer 3.35 North National Highway, Bgy. Tiniguiban, Puerto Princesa City in the below stated schedule:

Pre bid conference, and deadline for the submission/opening of bids shall be in PALECO BAC Room, **at 2:00 p.m. on November 24, and December 10, 2021**, respectively. Bid documents will be available to prospective bidders starting November 15, 2021 until 3:00 p.m. of December 9, 2021, upon payment of a non-refundable registration fee indicated above to the PALECO teller or through bank online payment. All bids must be accompanied by a bid security in form of cash, cashier/manager's check in the amount equivalent to two percent (2%) of the Approved Budget Cost.

The above project, funded out of the Department of Public Works and Highways (DPWH) shall be completed within the contract duration upon receipt of the Notice to Proceed.

Bidders are hereby expected to conduct due diligence prior to the pre-bid conference on the above stated projects.

PALECO hereby reserves the right to reject any or all bids, to waive any minor defects or infirmities therein, and to accept such bids as may be deemed advantageous to PALECO.
