- (1) Bid Security as prescribed in ITB Clause 18. If the bidder opts to submit the bid security in the form of:
- (i.i) a bank draft / guarantee or an irrevocable letter of credit issued by a foreign bank, it shall be accompanied by a confirmation from a Universal or Commercial Bank; or
- (i.ii) a surely bond accompanied by a certification coming from an authorized Insurance Commission that a surety or insurance company is authorized to issue such instrument;
- (6) Project Requirements, which shall include the following:
- (i.ii) Lists of contractor's personnel (viz, One (1) Project Engineer must be Registered Electrical Engineer and Registered Master Electricians / Authorized MOPRECO Electricians), to be assigned to the contract to be bid, with their complete qualification and experience data; and
- (i.iii) List of contractor's equipment units, which are owned, leased, and / or purchase agreements, supported by certification of availability of equipment from the lessor / vendor for the duration of the project; and

- (1) Bid Security as prescribed in ITB Clause 18.1. If the bidder opts to submit the bid security in the form of:
- (i.i) a bank draft / guarantee or an irrevocable letter of credit issued by a foreign bank, it shall be accompanied by a confirmation from a Universal or Commercial Bank; or
- (i.ii) a surety bond accompanied by a certification coming from an authorized Insurance Commission that a surety or insurance company is authorized to issue such instrument;
- (i.iii) Bid Securing Declaration as approved under GPPB resolution No. 03-2012
- (6) Project Requirements, which shall include the following:
- (i.ii) List of contractor's personnel (viz. One (1) Project Engineer - must be Registered Electrical Engineer Registered Master Electrician, and Six (6) MOPRECO Authorized Electricians. All with at least 1 year experience related to housewiring installation or any related field), to be assigned to the contract to be with their Valid Licenses Authorization, Certification / Trainings attended and Experience Data.
- (i.iii) List of contractor's equipment units, which are owned, leased, and / or purchase agreements, supported by Official Receipt / Certification of availability of equipment from the lessor / vendor for the duration of the project;
