INVITATION TO BID FOR THE SUPPLY OF CONDUCTOR DUPLEX #6 FOR SOLE USE

TARELCO I invite eligible bidders to bid for the "Supply of Conductor Duplex #6 for Sole Use".

Bidders are required to bid for the whole lot.

Conductor Duplex #6 - 229,000 meters

Approved Budget for the Contract (ABC) is Five Million Seven Hundred Twenty-Five Thousand Five Hundred Pesos (₱ 5,725,500.00). Source of fund for the said project shall come from the Sole Use Fund. Quoted price must be inclusive of VAT.

Delivery of materials must be completed within thirty (30) calendar days commencing upon receipt of Purchase Order and Notice to Proceed.

Potential bidders must submit their company profile, latest audited financial statement and pay an accreditation fee of Two Thousand Pesos (P2,000.00) before they are allowed to participate in the bidding process. Interested eligible bidders may inspect the bidding documents and/or obtain a copy upon payment of a non-refundable fee amounting to Ten Thousand Pesos (₱ 10,000.00) for the cost of bidding documents.

All fees must be deposited to the BAC's bank account to be provided by the Secretariat. A scanned copy of the deposit slip must be emailed to the Secretariat, once the payment was confirmed, an electronic copy of the bidding documents and official receipt shall be emailed to the prospective bidder.

A complete set of bidding documents may be purchased starting **November 28, 2021 until 4:00 P.M. of December 4, 2021** by eligible bidders upon submission of a written application to the BAC Secretariat.

Pre-bid Conference through a videoconferencing using zoom app shall be held on **December 6, 2021 3:00PM** at the TARELCO I Board Room. Questions and clarifications regarding the bid documents must be submitted on or before **December 5, 2021**.

Bidders shall send their sealed proposals via courier and must be received by the BAC on or before **December 19, 2021**, proof of shipping must be submitted to the Secretariat as evidence. Bid Opening shall be live streamed via zoom app on **December 20, 2021 2:00PM** in which the said proposals will be opened and read in the presence of Bidders or Bidders' representative who choose to attend. Late submission of sealed bid will not be considered or accepted.

The meeting ID and password shall be sent to all bidders' email address three (3) days before the schedule of pre-bid conference and bid opening. Only one (1) access per company shall be allowed.
