

- All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 15**.

9. Bid opening shall be on **December 27, 2021 at 9:00 AM** at the given address below and through *videoconferencing*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The *Quirino Electric Cooperative (QUIRELCO)* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
