Only those bidders who have bought the bidding documents shall be allowed to attend or participate during the pre-bid conference where attendance is MANDATORY. Due to the COVID-19 pandemic, the attendance for both the Pre-bid Conference and Bid Opening through video conference via zoom link will be applicable.
