## INVITATION TO BID FOR THE PROCUREMENT OF SPECIALIZED MAN LIFT TRUCK

TARELCO I invite eligible bidders to bid for the “Procurement of Specialized Man Lift Truck”.

Bidders are required to bid for the whole lot.

### **1 unit – SPECIALIZED MAN LIFT TRUCK**

Approved Budget for the Contract (ABC) is **Fifteen Million One Hundred Thirteen Thousand Two Hundred Ninety-Four Pesos (₱ 15, 113, 294.00)**. Source of fund for the said project shall come from the **Reinvestment Fund for Sustainable Capital Expenditures (RFSC)**. Quoted price must be inclusive of VAT.

Delivery of materials must be completed within **one hundred twenty (120) calendar days** commencing upon receipt of Purchase Order and Notice to Proceed.

Potential bidders must submit their letter of intent to join the bidding, company profile, latest audited financial statement and pay an accreditation fee of Two Thousand Pesos (P2, 000.00) before they are allowed to participate in the bidding process. Interested eligible bidders may inspect the bidding documents and/or obtain a copy upon payment of a non-refundable fee amounting to Twenty-Five Thousand Pesos (₱ 25, 000.00).

All fees must be deposited to the BAC’s bank account to be provided by the Secretariat. A scanned copy of the deposit slip must be emailed to the Secretariat, once the payment was confirmed, an electronic copy of the bidding documents and official receipt shall be emailed to the prospective bidder.

A complete set of bidding documents may be purchased starting **December 12, 2021 until 4:00 P.M. of December 18, 2021** by eligible bidders upon submission of a written application to the BAC Secretariat.

Pre-bid Conference through a videoconferencing using zoom app shall be held on **December 20, 2021 2:00P.M.** at the TARELCO I Board Room. Questions and clarifications regarding the bid documents must be submitted on or before **December 19, 2021. Questions and clarifications not submitted on or before the given date shall not be entertained during the pre-bid conference.**

Bidders shall send their sealed proposals via courier and must be received by the BAC on or before **January 2, 2022**, proof of shipping must be submitted to the Secretariat as evidence. Bid Opening shall be live streamed via zoom app on **January 3, 2022 2:00PM** in which the said proposals will be opened and read in the presence of Bidders or Bidders’ representative who choose to attend. Late submission of sealed bid will not be considered or accepted.

The meeting ID and password shall be sent to all bidders’ email address three (3) days before the schedule of pre-bid conference and bid opening. Only one (1) access per company shall be allowed.

All bids submitted must be accompanied by a Bid Security in an amount of not less than two percent (2%) of the ABC. For further information, please contact **VICTOR FLOREM B.
